DOUDS STONE LLC CREDIT TERMS AND POLICIES COMMERCIAL AND CONSUMER

We welcome the opportunity to extend you credit for the purchases made from Douds Stone LLC. For this privilege we request that you follow our credit terms and policies.

All credit purchases are due Net 30 Days. This means all purchases in a month must be paid by the 15th day of the following month. If the credit purchases are not paid by the end of the month due, the account becomes 30 days past due.

Finance charges in the amount of 1.50% (18% annual) will be charged on all accounts past due 45 days or more.

If any account becomes past due by 60 days, credit will be suspended immediately. All future purchases will be on a cash only basis. Cash would need to be in the form of a certified check, money order or currency of the United States of America.

If any account becomes past due by 90 days, all sales will be suspended to the customer. Sales could resume to the customer if one of the following conditions is met:

- 1. Account is brought current Credit privileges could resume at this time.
- 2. Account is brought within 60 days current Cash sales could resume to customer.

Customer shall pay all costs of collection of a past due account, including reasonable attorney's fees.
